With reference to the total voluntary public tender offer (the "Offer" or the "Tender Offer") pursuant to Articles 102 et seq. of Legislative Decree No. 58/1998 (the "TUF") promoted by S.G.G. Holding S.p.A. (the "Offeror") on the shares of SAES Getters S.p.A. (the "Issuer" or "SAES Getters" or "SAES"), the Offeror announces that on the date hereof, through Mediobanca – Banca di Credito Finanziario S.p.A., has carried out the purchase transactions on no. 39,941 Shares, to be disclosed pursuant to article 41, paragraph 2, letter c), of the Issuer's Regulations.

The purchase transactions have been carried out for a consideration not exceeding Euro 28.0 per SAES Share (*i.e.*, the Consideration of the Offer).

As a result of the above purchase transactions, as of today's date, the Offeror holds no. 5,417,405 Shares, representing approx. 32.27% of the Issuer's share capital.

Therefore, taking into account (i) the no. 5,417,405 Shares held by the Offeror, representing approx. 32.27% of the Issuer's share capital and (ii) the no. 10,198,017 Shares tendered to the Offer up to today's date (included), representing approx. 60.76% of the Issuer's share capital, the Offeror and the Persons Acting in Concert, upon completion of the Offer, will hold no. 15,615,422 Shares, representing approx. 93.03% of the Issuer's share capital.
